- 1) HE/SHE DOES HEREBY WAIVE AND RELEASE ANY AND ALL CLAIMS THE UNDERSIGNED MAY HAVE AGAINST THE HOST(S), ITS OFFICERS, DIRECTORS, OR TRUSTEES AND ITS COMMITTEE MEMBERS, MEASURERS, JUDGES, AGENTS AND REPRESENTATIVES ARISING OUT OF THE ACTIVITIES REQUIRED FOR THE RACES ON THE WATER, AND DOES FURTHER COVENANT AND AGREE NOT TO SUE OR TO BRING ANY CLAIM OR CLAIMS OF ANY NATURE WHATSOEVER AGAINST THE HOST ORGANIZATION(S) OR ANY OF THE PERSONS AND OFFICES NAMED, OR UNNAMED, ABOVE WHO MAY BE ACTING ON BEHALF OF THE HOST(S).
- 2) HE/SHE WILL BE RESPONSIBLE FOR ANY DAMAGE TO THE HOST CLUB AND FACILITIES THAT IS CAUSED BY SELF, FAMILY OR CREW WHILE ATTENDING THE REGATTA. ANY DAMAGE/PROBLEMS MUST BE PROMPTLY REPORTED TO THE HOST(S).
- 3) HE/SHE WILL BE FINANCIALLY RESPONSIBLE FOR ANY PURCHASES MADE AT THE CANANDAIGUA YACHT CLUB DURING THE REGATTA BY CREW OR FAMILY.

The undersigned hereby BELIEVES THAT HIS/HER YACHT, ITS RIGGING AND ITS CREW ARE SOUND AND IN CONDITION TO RACE. THE DECISION TO RACE IS SOLELY MINE. IT IS MY RESPONSIBILITY TO PROVIDE ADEQUATE SAFETY EQUIPMENT AND INSURANCE FOR MYSELF, MY CREW, AND BOAT. I AGREE, THEREFORE, THAT NEITHER I, NOR MY CREW WILL HOLD THE MEMBERS OF THE CANANDAIGUA YACHT CLUB, THE RACE COMMITTEE OR ANY REGATTA OFFICIAL LIABLE IN ANY WAY FOR DAMAGE TO MY YACHT OR FOR ANY LOSS OF LIFE OR INJURY TO MYSELF OR MY CREW. MY YACHT IS COVERED BY APPROPRIATE LIABILITY INSURANCE COVERING ALL POTENTIAL LIABILITIES ASSOCIATED WITH COMPETING IN THIS REGATTA.

We need to know if you plan to camp at CYC during the regatta. If so, please sign and return this page. This will also be available at regatta check in and at the CYC Bar area when you register with the Club Manager to camp.

CYC camping rules:

1. CYC has a permit to provide temporary campgrounds for its members and their guests who are attending sailing and/or social events.
2. Camping units are limited to tents, camping trailers and recreational vehicles.
3. **ALL CAMPERS MUST REGISTER** at the Clubhouse. Registration includes filling out the registration form, receiving a copy of the camping and swimming rules, reading the rules and signing the form agreeing to abide by these rules. (The registration information is located in the Clubhouse bar area.)
4. Camping is restricted to members, members' guests (sponsor must be camping at the same time) and regatta/event participants.
5. No one under 21 is permitted to camp without an adult.
6. **Open fires are allowed only in the two designated concrete pits.** All other fires are confined to grills, camp stoves, hibachis, etc. (A fire extinguisher is near each pit and one is near the grill.)
7. The Town of Canandaigua's **noise ordinance goes into effect at 10 p.m.** Please be courteous to our neighbors and your fellow campers by refraining from loud talking, laughter, etc. after 10 p.m.
8. An outdoor water faucet is provided but electrical and water connections are NOT available.
9. Showers, washbasin and bathroom facilities are on the ground floor of the Clubhouse. During the season, members and guest campers have 24 hour access to this area. After 10 p.m. the noise level in these areas must also be kept to a minimum.
10. Food, liquor, wine, etc. may NOT be consumed anywhere in the Clubhouse, on the porch or on the patio unless it has been purchased from CYC.
11. The camping area should be kept clean! Receptacles have been provided for this purpose.
12. Pets are allowed but must be kept on a leash. They should not be allowed to annoy anyone and they must be cleaned up after!
13. If parking near the camping area, please be careful when the ground is soggy to avoid getting stuck. Please park perpendicular to the slope to avoid a runaway car. Don't park in the sports/game area or block the entrances to the camping area itself.

I have read and understand the CYC camping rules and will abide by them during my participation in the J-22 Fleet Jackrabbit Regatta.
