Insurance: Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$100,000 per event or the equivalent. Insurer and policy number is required on registration form.

Canandaigua Lake Watershed Management

For the good health of Canandaigua Lake, and in accordance with NYS Law, CYC asks that all boats arriving at Canandaigua Lake be clean, dry and drained. You may not:

- Transport aquatic invasive plants or animals
- Transport watercraft without draining water, removing drain plug, and leaving all water draining devices open
- Launch a boat or personal watercraft, or place a trailer in water if it has invasive plants or animals attached
- Dispose of unwanted live bait in water or on ground near a lake or stream.

CYC has an approved Disposal Station for plant and animal debris from boats and trailers.
