CREW LIABILITY WAIVER FORM

As a Condition to Sailing in Races Sponsored by Canandaigua Yacht

I HEREBY CERTIFY THAT:

In consideration of the efforts of the host organization(s), for being allowed to participate in this regatta and the acceptance of this application to race:

- 1) HE/SHE DOES HEREBY WAIVE AND RELEASE ANY AND ALL CLAIMS THE UNDERSIGNED MAY HAVE AGAINST THE HOST(S), ITS OFFICERS, DIRECTORS, OR TRUSTEES AND ITS COMMITTEE MEMBERS, MEASURERS, JUDGES, AGENTS AND REPRESENTATIVES ARISING OUT OF THE ACTIVITIES REQUIRED FOR THE RACES ON THE WATER, AND DOES FURTHER COVENANT AND AGREE NOT TO SUE OR TO BRING ANY CLAIM OR CLAIMS OF ANY NATURE WHATSOEVER AGAINST THE HOST ORGANIZATION(S) OR ANY OF THE PERSONS AND OFFICES NAMED, OR UNNAMED, ABOVE WHO MAY BE ACTING ON BEHALF OF THE HOST(S).
- 2) HE/SHE WILL BE RESPONSIBLE FOR ANY DAMAGE TO THE HOST CLUB AND FACILITIES THAT IS CAUSED BY SELF OR FAMILY WHILE ATTENDING THE REGATTA. ANY DAMAGE/PROBLEMS MUST BE PROMPTLY REPORTED TO THE HOST(S).
- 3) HE/SHE WILL BE FINANCIALLY RESPONSIBLE FOR ANY PURCHASES MADE AT THE CANANDAIGUA YACHT CLUB DURING THE REGATTA BY SELF OR FAMILY.

The undersigned acknowledge that participation in the sport of sailing involves substantial risk of personal injury or even death and the undersigned hereby assume the risk of such injury that may occur while participating in the event.
